





**Exhibit 2.3.2** Weekly percent positivity in those tested for COVID-19 in Toronto, by immigration category, January 15 to November 7, 2020




**Exhibit 3.1.1** Proportion of Toronto residents tested for COVID-19, by immigration status, age group and sex, as of November 1, 2020



**Exhibit 3.1.2** Percent positivity in those tested for COVID-19 in Toronto, by immigration status, age group and sex, as of November 1, 2020









**Exhibit 5.1.1** Proportion of those tested for COVID-19, by world region of birth of immigrants and refugees in Toronto, as of November 1, 2020
















Medical conditions have not been reported for recent OHIP registrants, as many have not had sufficient time in Ontario to contribute the necessary health care use data to allow for identification of these conditions.

Respiratory conditions encompass asthma and chronic obstructive pulmonary disease. Cardiovascular conditions encompass heart failure, history of transient ischemic attack or stroke, hypertension and ischemic heart disease. Inflammatory conditions encompass inflammatory bowel disease and rheumatoid arthritis. These chronic conditions are identified using validated algorithms in ICES data holdings. The latest diagnosis date is March 31, 2019.




**Exhibit 8.2** Proportion of health care workers among COVID-19 cases in Toronto adults older than 18 years, by immigration category, as of November 1, 2020
